

COVENTRY STADIUM

While I was still working at Birmingham City Council on the GBSEP Spatial Plan I mentioned to Anna Rose that I was concerned about proposals for the demolition and redevelopment of Coventry Stadium with my particular interest being a follower of the Stock Car Racing.

Since then I have been in touch with Pete Lawrence who has established a Facebook Group seeking to protect the stadium. Pete is a follower of Coventry Speedway.

I have been seeking a meeting with Frampton's who are acting on behalf of the prospective developer to try to establish the current position and intentions but this has, thus far, not met with a positive response. We must therefore assume it is still proposed to submit a planning application for housing.

I was wondering if you would be prepared to meet Pete Lawrence and myself to discuss the threat to the Stadium and how we might best respond to this, including the recent decision to protect the stadium in Oxford by designation of facility as a Conservation Area?

Coventry Stadium is the equivalent of Wembley Stadium to the sport of Stock Car Racing so the redevelopment proposals raises very serious concerns.

If we are able to meet can I suggest that Nick Freer might also attend as I understand he has previously been involved in discussions/correspondence on this matter.


