## (PART OF FOOTPATH R190 BOURTON ON DUNSMORE) PUBLIC PATH ORDER 2024

This Order is made by the Rugby Borough Council ("the Council") under Section 257 of the Town and Country Planning Act 1990 because it is satisfied that it is necessary to stop up part of **Footpath R190** and create a new **footpath** to which this Order relates in order to enable development to be carried out in accordance with the pending planning permission under Part III of the Town and Country Planning Act 1990 by the Council for the erection of a dwelling with associated parking and boundary treatments Reference Number R23/0365

#### BY THIS ORDER

- Part of the footpath R190 shown by a continuous black line on the attached map and described in Part 1 of the Schedule to the Order ("the Schedule") shall be stopped up as provided below.
- 2. There shall be created to the reasonable satisfaction of the Council an alternative footpath R190 for use as a replacement for the said part of footpath R190 provided in Part 2 of the Schedule and shown by black dashes on the attached map
- The stopping up of the **footpath** shall have the effect on the date on which the Council certify that the terms of Article 2 above have been complied with.

- 4. Where immediately before the date on which the **footpath** to be stopped up there is apparently under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they had
- The following works shall be carried out in relation to the highway described in Part 2 of the Schedule

The footpath will be 3 metres wide of self binding gravel

#### Between Points A-B-C


Stop up the existing footpath point A (grid reference 43370 70627) curving westerly for approximately 87 metres to Point B (grid reference 43295 70638) turning northerly for approximately 12 metres to Point C (grid reference 43270 70638)

#### PART 2


### DESCRIPTION OF SITE OF NEW FOOTPATH Between Points A-D-E on the Order Plan

Point A (grid reference 43370 70627) westerly for approximately 21 metres to Point D (grid reference 43345 70634) turning northerly for approximately 24 metres to Point E (grid reference 43340 70658)

The footpath will be 3 metres wide of self binding gravel
