The 'Main Rural Settlement' definition is not sound. New growth should be accommodated in the Rugby Urban Area rather than in less well served remote rural areas like Wolvey. Wolvey's infrastructure in terms of primary and secondary schools, GP services and transport availability are extremely limited. High car dependency and the subsequent increase in traffic would not be sustainable. The proposed site is within the Green Belt which is also contrary to Government Policy. Furtherance landscape studies have indicated that this land is unsuitable for housing development.
