Wolvey is the smallest village and least well served of all the Rural Villages yet has the third highest housing allocation. The proposed allocation of up to 210 houses in Wolvey are within Green Belt areas which is contrary to Government policy. The land north of B4109 is adjacent to a local Wildlife site and the ecological impacts have not been assessed.
 Wolvey's infrastructure could not support the added pressure on its primary school, GP services and limited public transport. Children attending secondary school would have to travel to surrounding towns. (Continue on a separate sheet /expand box if necessary)
