I object to allocating Lawfields Field Farm for 250 dwellings in RBC's proposed local plan.

Allocating Lawfields Field Farm in the local plan is neither justified nor consistent with national planning policy.

The sequence of events is as follows:

- In March 2025 Rugby Borough Council quite rightly agreed that it would be wrong to include Lawford Fields Farm in their proposed plan and went out for consultation on that basis;
- Rugby Borough Council decided to put some of their own land into the planning mix and take two years off the plan period. This reduced the need to allocate greenbelt sites;
- Then last October Rugby Borough Council received a report from its consultants showing that the Lawford Fields Farm site was not only in the Green Belt but in the very highest category of Green Belt; and
- Yet despite this evidence in January this year Rugby Borough Council voted to add this site to their local plan.

Back in 2025 Rugby Borough Council's "sustainability consultants" thought their decision not to put houses on Lawford Fields Farm was the right one. Comparing it to sites which had been included they wrote that the Lawford Fields Farm site is

"considered to perform less well for two reasons, namely: 1) Green Belt noting that this land is not likely to comprise Grey Belt on the basis of contributing to avoiding the sprawl of Rugby as a large built-up area; and 2) the site would not link as well to the village centre". They went further writing "There is no clear case for large-scale growth of this nature at Long Lawford".

Last autumn another one of Rugby Borough Council's consultants wrote "Development of land in the parcel would have an incongruous impact on the urban pattern. The lack of features to restrict and contain development mean that development here would have an incongruous impact, and would contribute to sprawl associated with the large built up area of Rugby".

So going from not allocating this site in March 2025 to allocating this site just ten months later goes against the run of evidence Rugby Borough Council received during this time. The only argument Rugby Borough Council have produced is that after writing their March 2025 plan they found out how good transport services are to Long Lawford (On weekdays the number 86 bus service runs about once an hour).

The government's planning policy is set out in the National Planning Policy Framework. It says "Green Belt boundaries should only be altered where exceptional circumstances are fully evidenced and justified through the preparation or updating of plans. Where it is necessary to release Green Belt land for development, plans should give priority to previously developed land, then consider grey belt which is not previously developed, and then other Green Belt locations".

Lawfords Field Farm is not previously developed. Lawfords Field Farm is not grey belt. It is in the very last part of the Green Belt which should be considered for development.

If Lawford Fields Farm was removed from RBC's plans they would still be allocating room for 11,479 houses which is 667 more houses than the 10,812 the Secretary of State is telling them to find.

There is no case for allocating Lawford Fields Farm for housing.
