I was the **only** resident of Rugby that took part in the last Inspectors Review and would like the opportunity to raise this issue again at the next one.

Regarding the incessant spread of warehousing in Rugby Southwest, it does not seem to meet the original aim of **employment**. The original aim (reason for the build) was 2500 employees and figures readily available don't support that. A huge sacrifice of agricultural land. Since the build the area has suffered light pollution, apparent impact on the bird population and flooding in the village of Thurlaston. No more warehouses please.

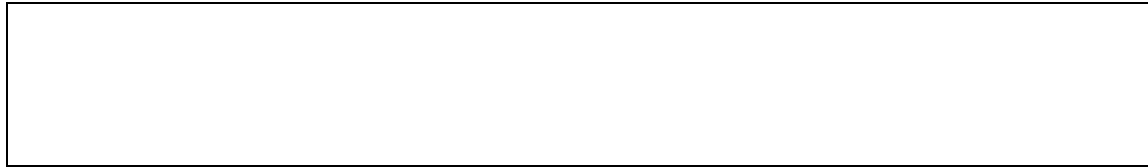
