The plan is not justified and is not consistent with National policy

- You are proposing a disproportionate number of houses for a small village
- The proposal is within the green belt
- The land is not suitable for housing
- A full ecology assessment has not been undertaken and the site abuts a local wildlife site
- Wolvey's infrastructure does not support 150 + 60 new homes. The schools are full, and transport is a major issue. There is no local access to shops, GP'S, chemists or dentists
- Wolvey is notably a small main rural settlement are – as per your own sustainability appraisal

- Traffic flow through the village is already particularly heavy and causing issues.
- The council's own sustainability appraisal does not support this housing development
- There is no specialist school provision or educational infrastructure at senior level.
