The proposal for site 337 adds a significant number of new dwellings which is disproportionate to the size of the existing village, even without the addition of the proposed properties at site 315. Addition of a further 75 properties as proposed will cause many problems in an area already struggling with poor facilities, including traffic, infrastructure overload, and shortage of medical services.

I would therefore suggest that site 337 should be reduced to only include the conversion of the existing farm buildings and new build should be removed from the plan, this will reduce the additional stress on the existing stretched village resources and maintain the character of the village.

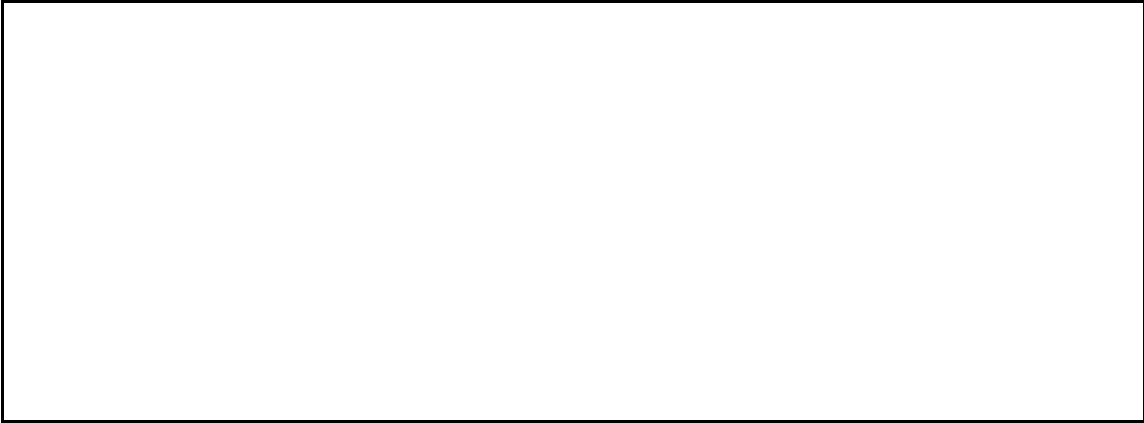
