The proposed development at Newton Manor Lane has not been very thought out. Brownsover already suffers from a lack of shops/cafes/restaurants that are easily accessible by foot. Cars are essential for employment opportunities and leisure activities. Newton Manor Lane is a dangerous road as it is which only very recently had its speed limit reduced due to the number of accidents on it. Funnily enough this road has no footpath, and you are proposing building homes on it. The residents in this rural area will be dependent on cars. The junction at the St Thomas Cross is very dangerous. You propose including bus stops in the development to serve the houses, however there is no bus route which serves the area and also the bus stops are not planned to be recessed from the road, meaning dangerous overtaking and the already mentioned dangerous road. I highly recommend you study the floodplain correctly which is located at the bottom of Staveley Way (it's all well and good saying that the development will not be of flood risk itself but what about the surrounding

area further downhill?) I myself manned a rubber dinghy in the field approx 5 years ago during floods, and it was scarily close to the houses then. With this proposed loss of green space and the nearby warehousing development adjacent to the Grand Central Walk (don't get me started on that) - the flood risk will be dangerous. WHY WHY WHY are you looking to strangle the wonderful green space that is the grand central walk by straddling it with 2 developments either side?
