I consider policy S1 to be unsound in that it does not appear justified by the supporting evidence.
 I feel that the Rugby urban area should actually accommodate the majority of new growth and not the remote and less well-served rural areas.
 The definition of the 'Main Rural Settlements' is actually not sound – Wolvey has been given the third highest allocation for housing but is actually the smallest and least well-served of all the Rural Villages

I consider Policy S2 to be unsound because it provides the basis for an unsustainable pattern of development that is actually not 'justified' by the evidence. It does not reflect the overall preferred strategy of Urban Concentration, and it proposes nearly 58% of new allocations (over and above those in previous Local Plans and already with permission) in the rural areas.

This Draft Local Plan seeks to allocate some 1,500 new homes on land that would need to be released from the established Green Belt. This does not protect Green Belt. There are development options outside of the Green Belt that should be explored.

The Council's evidence seeks to identify large areas of Green Belt as 'Grey belt'. These areas are needed to safeguard the countryside from encroachment, preventing urban sprawl and maintaining openness. The plan does not follow the National Planning Policy Framework to only allow changes to Green Belt in exceptional circumstances

The land north of B4109, Wolvey should not be allocated for housing for the reasons set out below:

- 150 new homes are of a disproportionate scale to the size of the current village
- The proposed allocation is within Green Belt, this is contrary to Government Policy
- Previous landscape studies that have been conducted indicated that the land has 'High sensitivity to housing development'. This cannot therefore be a suitable proposal
- Part of the site (309) is next to a Local Wildlife Site. There has not been a sufficient assessment of the ecological impact of any development in this area
- 150 homes (and up to 210 homes with the 2nd site) is too much for Wolvey's infrastructure in terms of pressure on the primary school, travel to secondary schools, its GP practice, and also its very limited public transport provision
- The Council's own Sustainability Appraisal indicates that Wolvey is a small rural settlement with a low settlement score

The allocations proposed in the Local Plan do not reflect the available evidence in terms of impacts on the landscape. In particular for the site at Land north of B4109, previous evidence has indicated that the site has 'High sensitivity to housing development' in landscape terms. Design policies D1 to D5 that seek to improve design quality are welcome. However the scale of development proposed for Wolvey (a 60% increase in village size) would harm local character and its rural setting

Policy D5 does not appear to address the current flood areas within villages and how water drainage in an existing flood area could be effectively managed without polluting existing waterways and worsening any flood risk. Wolvey already has experience that SuDs are not sufficient and flooding has dramatically increased with recent housing development on areas close to the River Anker.

Additionally, the policy does not take into account the pressure that would be placed on an already struggling wastewater system
