Firstly the question of sewage works. Last updated in 1967. Next update scheduled for 2045. Not fit for purpose. Water including waste water already backs up into house in Heath lane, Duncow Close and Coventry Road. Secondly traffic congestion. The proposal shows exit from the new dwellings from Brays Close and Heath Lane. These area's have massive congestion at certain times of the day. Reasonable to assume that new dwellings would add considerable traffic flow at school times and works times. I think this would be impact considerably on the present flow. Bearing in mind Broad Street is in fact the Fosse Way and as such is used by large amounts of traffic going to Magna Park and the A5.
