The proposed site in North Road in Clifton upon Dunsmore is on the corner of a tight bend which has poor visibility. It is also very close to the entry point to the adjacent allotment site and 2 neighbouring properties. There is a single pathway on this side of North Road often used by school children. North Road is also quite narrow and can become congested with school related parking. For this reason the entry point is unsuitable for multiple properties. A road safety audit must be carried out to ensure suitability for the additional traffic this proposed development will generate, including HGVs ie bin lorries, removal lorries etc. I would like to add that the maximum combined access and pavement space for the proposed entry point is less than 7m wide which is bordered by 3 existing vehicle access points. I understand from the Highways Agency the minimum road width for 2 way traffic is 6.75m not including the pavement. Note this is compounded by a blind 90° corner.
