1. Severe Highway Safety Risks Adjacent to Rugby Free Primary School
 The proposed sole vehicular access to the industrial site via Central Park Drive will necessitate all HGV and employee traffic passing directly in front of Rugby Free Primary School (1 Bailey Road, CV23 0PD). This route intersects with the school's main pedestrian entrance and play areas, creating an unacceptable risk to child safety.

- Contravenes NPPF Paragraph 111, which requires developments to ensure safe and suitable access for all users.
- Breaches Rugby Local Plan Policy D2 (Access and Highway Safety).

2. Inadequate Assessment of Cumulative Traffic Impact
 The Transport Assessment fails to address cumulative impacts from existing and committed developments in the Coton Park area.

- Contrary to Policy TR1 (Transport) and Policy HS5 (Health and Wellbeing) of the Local Plan.

- Absence of a robust Travel Plan and mitigation strategy renders the application deficient under Regulation 122 of the Community Infrastructure Levy Regulations 2010.

3. Conflict with Child Welfare and Public Health Objectives

The proximity of an industrial estate to a primary school raises serious concerns regarding air quality, noise, and visual intrusion.

- Increased HGV traffic will elevate NO₂ and particulate emissions, undermining compliance with Air Quality Management Area objectives and NPPF Paragraph 185 on avoiding significant adverse impacts on health.
- Disregards Policy SDC9 (Health Impact Assessments).

4. Non-Conformity with Local Development Plan and SPD

The Cotton Park East Supplementary Planning Document envisages a balanced mix of uses with appropriate buffers and green infrastructure. The current proposal for large-scale industrial logistics fails to provide adequate separation from sensitive receptors such as schools and residential areas.

- Represents a material departure from the adopted spatial strategy and should be refused under Section 38(6) of the Planning and Compulsory Purchase Act 2004.
