FURTHER CONSIDERATION OF THE IMPACT OF BRINGING LARGE NUMBERS OF EXTRA PEOPLE TO LIVE IN VILLAGES, IN PARTICULAR BRINKLOW, WHERE THE PLAN IS TO VIRTUALLY DOUBLE THE SIZE OF THAT VILLAGE. THIS AFFECTS VILLAGES LIKE MONKS KIRBY WHICH, FOR MANY YEARS, HAS EXPERIENCED ADVERSE EFFECTS OF EXPANDING THE PRIMARY SCHOOL LOCATED THERE AND THIS CAN ONLY GET WORSE WITH MORE CHILDREN BEING MOVED INTO THE CATCHMENT AREA (I.E. BRINKLOW). IT HAS BEEN REPORTED THAT AT ONE OF THE PUBLIC MEETINGS IN BRINKLOW, WHEN THIS MATTER WAS BROUGHT UP, A RUGBY BOROUGH COUNCIL OFFICER DISMISSED THE CONCERN AS, AND I QUOTE "IT WOULD ONLY MEAN AN EXTRA 2 COACHES PER DAY" TO BRING THE ADDITIONAL BRINKLOW CHILDREN TO THE MONKS KIRBY SCHOOL. THIS NAIVE ATTITUDE IS APPALLING! WHAT WILL HAPPEN IS THERE WILL BE A MASSIVE INCREASE IN THE NUMBER OF CARS BRINGING CHILDREN TO SCHOOL - MONKS KIRBY IS ALREADY OVERWHELMED WITH CARS TWICE PER DAY WITH PARENTS DELIVERING OR COLLECTING THEIR CHILDREN. THE ROADS ARE BLOCKED WITH CARS AND THIS WILL ONLY GET WORSE AND IS TOTALLY UNACCEPTABLE. FURTHERMORE, THE DOCTORS REVEL SURGERY IS ALREADY AT NEAR CAPACITY FOR PATIENTS AND AN EXTRA 325 HOUSES WILL SWAMP THE SURGERY. THERE HAS BEEN NO CONSIDERATION OF EITHER OF THESE TWO MATTERS.
