I also undertook a survey of on the use of 2 Pelican crossing on Crick Rd and High St which are situated on the A426, during the hours of 8.0am and 9.0am .
The crossing were activated on average 75 time an hour.
I consider the A426 is near saturation , and to reduce or control are required, any further expansion of Hillmorton and the surrounding areas will only make the situation worse.
