I object against this proposed windfarm site citing Section 15 of the National Planning Policy which focuses on conserving and enhancing the natural environment and would draw your attention to the points below which go against this;

1. **Visual Impact**: The installation of wind turbines in such close proximity to residential areas will significantly alter the landscape and may detract from the natural beauty of our surroundings, affecting property values and the quality of life for residents.
2. **Noise Pollution**: Wind turbines can produce noise that may be disruptive, particularly during quiet hours. This could lead to disturbances for families, especially those with young children or elderly members.
3. **Wildlife Disruption**: The proposed site is home to various wildlife species including protected Great Crested Newts, short eared owls, deer, swans, geese and ducks who regularly fly across the area and use the brook that spans the land. I have personally seen all of the mentioned wildlife. The construction and operation of a wind farm could disrupt their natural habitats, leading to potential ecological imbalances and potentially endanger their lives.
5. **Community Engagement**: It appears that the community has not been adequately consulted regarding this project. Residents deserve a say in developments that will affect their homes and livelihoods. I urge you to reconsider the implications of this wind farm on our community and to explore alternative locations that would minimize disruption and still contribute to our renewable energy goals. Locally around the A5 corridor there is plentiful scope to site these wind turbines.
