I am a resident of Coton Park and wish to object to the Proposed Submission Local Plan on the grounds that the plan fails to properly assess, mitigate, or evidence the air-quality impacts arising from major allocations in the north Rugby area, particularly Site 64 (Coton Park East) and Site 59 (Newton Manor Lane).

The plan is unsound because it does not meet the requirements of Policy EN9, EN8, the NPPF, or the statutory duty to protect public health.

1. The plan provides no air quality modelling for the largest HGV generating allocation in the

borough.

2. The plan fails to assess cumulative impacts in the locality.
3. The plan does not assess any impact on residential streets, school routes, great central walk local wildlife site..
4. There is no mitigation strategy provided.

2. Removal of overnight lorry parking from site 64.
3. A minimum 100-150m landscape buffer between industrial users and homes
4. Binding air quality mitigation measure
5. Reassessment of site 64 suitability for housing given it's proximity to homes
6. HGV only axis from M6 J one side and not via the residential roads
7. Publication of air quality evidence before any adoption and recon consultation with residents.
