When i attended the first presentation of the plan the land for the school (literally the only positive i could see), was posited by representatives as "gifted" for the local community. Following a developer meeting, the school are now aware they would have to purchase it for £3 million. So we were lied to. Clearly a rouse to make it look like a gesture of good will to keep residents happy, which the school could never afford, and would just be sold on for a

tidy profit after the fact. They must think Rugby council and the residents are stupid. Not only should this be completely over turned , but the developer should be taken to court for miss representation/fraud and their previous developments scrutinised.
