SWFT have not yet been engaged by the Council on developing the local plan. SWFT deliver community health services to residents of Rugby Borough, and there are also an increasing number of Rugby Borough residents attending the emergency department at Warwick Hospital.

The proposed housing developments in the local plan will increase demand on SWFT services. The Trust's current capacity is already maximised and will not be able to absorb the increased demand for health care. This will require mitigation in the form of contributions towards additional healthcare infrastructure to create the required capacity, to ensure this is compliant with current planning policies.

SWFT are seeking engagement with the Council on these impacts, and assurance that there will be Council support to mitigate the impact on local health services from the proposed developments, in compliance with the CIL 122 test.

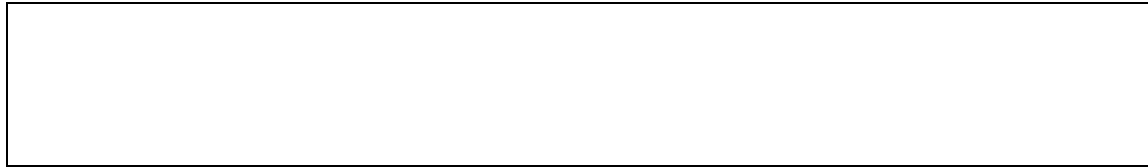
