There are 2 main reasons for my concern:

1) Access and traffic: Although primary access is through the industrial estate, the secondary access past the primary school still creates significant risk to the children. This access should be emergency vehicle only and gated to enforce. The infrastructure further up, particularly the Aldi roundabout and M1 roundabout are already heavily congested and will not cope with the additional industrial and employee traffic. The knock on will be felt all along the Leicester Road.

2) Noise and Light pollution impacting local residents. The supply chain sector is a 24/7 industry and at early consultation meetings, the developers were unaware of what type of business would take on the leases of the new warehouses. Traffic, operating hours, material

handling and associated risks can not be assessed unless there is more detail on the specifics of those businesses. As such, they can not provide adequate reassurance around the impact to local residents.

1) No access other than emergency vehicle down Central Park Drive and the introduction a new junction between the M6 J1 and the Catthorpe interchange, specifically feeding the industrial area.
