UHCW haven't been engaged by the Council on developing the local plan. UHCW deliver acute hospital health services to residents of Rugby Borough and the net inward migration associated with the proposed housing developments in the local plan will increase demand on UHCW services.

The Trust's current capacity is already fully utilised (evidenced by long waits for elective care, bed occupancy rates consistently above good practice levels with percentages in the upper nineties, and delays to patients being seen in Accident and emergency and being transferred from ambulances.

To ensure this proposed development plan is compliant, the additional demand on public services needs to be mitigated – in this case via contributions towards additional healthcare infrastructure to create the required capacity.

UHCW are seeking engagement with the Council on these impacts, and assurance that there will be Council support to mitigate the impact on local health services from the proposed developments, in compliance with the CIL 122 test.

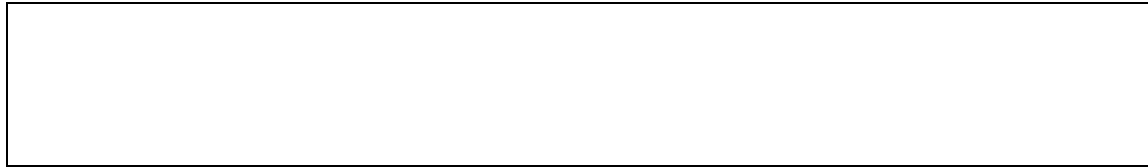
