## **Overview and Scrutiny Work Programme**

### Summary

The report updates the Committee on the progress of task group reviews within its remit and details the overview and scrutiny forward work programme.

### 1. CURRENT REVEWS

### 1.2 Access to Emergency Health Care Provision

The task and finish group commenced its work on 21 February, making some changes to the scoping paper and met again on 23 May. There has been a slight change to the membership as Councillor Mrs O'Rourke is no longer able to continue having been appointed as Mayor, and Councillor Willis has stepped down as being a member of Cabinet he is no longer eligible to sit on the task group. The membership of the task and finish group is now; Councillors Sandison (Chair), Mrs Hassell, Mistry, Mrs Roberts (Vice-Chair) and Roodhouse.

The next meeting is due to be held in September when a work programme will be agreed.

### 1.3 Managing Council Tax Arrears

The Task Group met on 16 February and 6 March. A draft review report was circulated to members of the task and finish group prior to submission to the Committee. This item is covered earlier on the meeting agenda.

#### **1.4 Development of a Landlord Forum**

As agreed at the meeting held on 30 January, a task and finish group will be formed to carry out research on the background to successful forums that exist elsewhere and to report back to the Committee on the possible next steps and terms of reference.

There had been a delay in the commencement of the review due to the preelection period but a call for volunteers has since been made and work was due to commence once the task and finish group was established.

#### 2. WORK PROGRAMME

#### 2.1 Current Work Programme

A copy of the current work programme is attached at Appendix 1. A table listing the motions from Council has been included for reference.

#### 2.2 Items Carried Forward

There are two historic items listed that date back to the 2020/21 municipal year:

#### Health and Wellbeing

The situation is a significantly different picture to when this topic was originally tabled. The Chief Executive chairs the Rugby Health and Wellbeing Partnership working with a broad range of partners to identify new priorities for the group going forward. The group is made up of representatives from Public Health, the Strategy team and UHCW and GP's. There is also pilot work being carried out around area-based action plans.

This work is already going through a scrutiny process with a broader range of stakeholders including elected Members. In view of this work already being carried out it is proposed that an update be provided at the next meeting and it will be considered whether this item remains in the work programme.

#### **Digital Inclusion**

The IT and Digital Strategy was considered and adopted by Council on 19 July 2022.

It is proposed that this is incorporated into the item involving a discussion on performance with the portfolio holder for the digital and communication service area.

#### 3. FORWARD PLAN
