The above premises has seen an increasing number of incidents within the last 3 ½ months which has resulted in a licensing visit being completed, and the brewery being contacted to discuss a way of reducing the incidents associated to the premises.

On Sunday 18th January 2026 at approximately 00:21 hours an assault took place whereby a member of door staff struck a member of the public to the head, in a seemingly unprovoked manner.

This strike caused the member of the public to fall to the floor and lose consciousness resulting in the following injuries, black eye, split lip, perforated ear drum and a small bleed on the brain.

The above matter is under investigation and the suspect in this matter has been interviewed and bailed whilst the investigation continues.

This matter has also been reported to the SIA for their review.

On further review of the incidents there have been 12 reported and the summary of these incidents can be seen below:

Log 22 of 05/10/2025 – Rugby CCTV reports of a fight in progress, involving 15 people and a bouncer chasing them. All parties dispersed, no complaints made.

Log 377 of 10/10/2025 – Rugby CCTV report of a staff member being assaulted, suspect detained, however no complaint made.

Log 25 of 11/10/2025 – Rugby CCTV reports of a fight on Sheep Street involving 15 people, some people dispersing and some heading back to Bar 29, no complaints made.

Log 35 of 12/10/2025 – Rugby CCTV report a fight taking place between door staff and a member of the public who has been ejected. Officers attended and seems to have been escalated by door staff, no complaints.

Log 43 of 18/10/2025 – Rugby CCTV report a fight at the premises. Officers attended and manager indicated there had been 3 different altercations, no complaints.

Log 25 of 19/10/2025 – Rugby CCTV report that a male has been punched to the ground outside the premises and is on the floor. Officers attended and in the process of dealing with the matter, 3 officers were assaulted and 2 arrests.

Log 415 of 07/11/2025 – Rugby CCTV report a fight outside the premises. Parties have been separated, but the male is trying to fight with someone inside. Male left on police arrival.

Logs 59 & 60 of 16/11/2025 – A group of males have smashed bottles outside Bar 29 and targeted door staff, who have then used bar furniture (metal poles) to defend themselves, but this has then led to further disorder.

Log 38 of 20/12/2025 – Report of 2 male members of door staff assaulting a member of the public inside the premises causing GBH level injuries (split eye and injuries to his face). This matter is still under investigation.

21/12/2025 – Following a licensing check, a male known to have had his SIA licence suspended is seen working on the entrance to the premises completing duties associated with door supervisors such as counting the numbers of people in the premises, controlling entry to the premises and conducting ID checks, therefore breaching his SIA conditions and those of the premises licence. During a licensing visit by Sgt Mackley on 21/11/2025, the owner and DPS confirmed that door staff are employed/arranged directly by themselves.

Log 110 of 01/01/2026 – Caller reporting that they have been smacked in the mouth by door staff who were pushing people towards the door due to a bottle being dropped, however callers was not involved.

Log 13 of 11/01/2026 – Rugby CCTV report that a male has come from the bar and has been taken to the ground outside of the bar. Further caller stating he has been assaulted by door staff after being ejected from the premises. (This is the same male as stated above in the grounds for this review).

The premises have proactively reported 2 incidents within the time frame that can be found on

innkeeper, 1 relating to a male and female being found in possession of drugs and an ejection due to a male behaving inappropriately towards staff.
