Hi Erica,

I had another look on site on Tuesday and as per previous comments there would be an major impact on that row of TPO Oak trees. One of the Oaks especially is the biggest and most prominent out of the group.

There is actually an existing gap (where a disused utility pylon is) to the south east of the proposed enrance and as shown in the TPO plan below (approx. 20 metres wide). Has that been considered for access?

Elsewhere and to the north western boundary near to where the football pitch is proposed a small area of tree removal is proposed. This is outside of the TPO tree group and consists mainly of young Poplar/Birch/Elder scrub. I have no objection to this but would object to the loss of mature TPO tree cover to form the new access and as per previous comments.
